AMENDMENT NO. 1 TO AGREEMENT BY & BETWEEN COUNTY OF MONTEREY & MSW CONSULTANTS, INC.

THIS Amendment No. 1 is made to the Agreement by and between MSW CONSULTANTS, INC. ("CONTRACTOR"), and the County of Monterey, a political subdivision of the State of California ("County").

WHEREAS, County and CONTRACTOR entered into an Agreement with a term of September 21, 2015 through July 30, 2020 for an amount not to exceed \$76,500 for the solid waste consulting services; and

WHEREAS, County and CONTRACTOR wish to amend the Agreement via Amendment No. 1 to increase the Agreement by \$18,500 for an amount not to exceed \$95,000.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the Agreement in the following manner:

- 1. Section 2.01, "PAYMENT PROVISIONS", is amended to read as follows: The County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$95,000.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect.
- 3. A copy of this Amendment No. 1 shall be attached to the Agreement and shall be incorporated therein as if fully set forth in the Agreement.
- 4. The recitals to this Amendment No. 1 are hereby incorporated by this reference.
