Lot # 6 as the same shown and designated on a Map entitled, "Fanny G. Porter Subdivision No. 3, Recorded on the 17th day of February 1941, in Volume 4, of Cities and Towns at Page 53, Records of Monterey County, California. (hereafter referred to as, "real property" or "premises")

Provided, however, that the herein described real property is being conveyed by County to District, for the sole purpose of creating and maintaining a public park or playground; and, that as long as said real property is so used, occupied, and maintained, it shall remain the property of District. If, however District shall fail to occupy, maintain or use the herein described real property as a public park or playground for a period of one (1) fiscal year, July 1 through June 30, then said real property shall revert to and vest in the County, and its successors and assigns in fee.
