WHEREAS, Ebby Johnson began her career with the County of Monterey in July 1979, as a Typist Clerk for the Planning and Building Inspections Department, and then promoted as Word Processor and Secretary to the Zoning Administrator; and

WHEREAS, Ebby Johnson transferred to Natividad Medical Center in November 1990, and was promoted to Senior Secretary to the Chief Operating Officer, and the Chief Financial Officer. During her tenure at Natividad Medical Center, she participated in the Move Committee from the old Natividad Hospital into the new Natividad Medical Center building; and

WHEREAS, on June 15, 2001, Ebby Johnson joined the County Administrative Office as the Administrative Secretary to the Chief Deputy Director. In December 2004, she was promoted to Administrative Secretary-Confidential to the Assistant County Administrative Officer, providing critical administrative support services during the County’s annual budget process, culminating in the production of the County’s annual recommended budget, and where she also served as the Committee Secretary for the Budget and Capital Improvement Committees; and

WHEREAS, Ebby Johnson was promoted to the Executive Assistant to the County Administrative Officer, Dr. Lew Bauman in December 2018, coordinating special projects, maintaining highly sensitive and confidential materials, participating in solving complex administrative issues, resolving complaints from citizens, and providing the Administrative Officer administrative advice and staff assistance having countywide impact; and, upon Dr. Bauman’s retirement, she served in the administration of Charles McKee.

WHEREAS, Ebby Johnson’s hard work and leadership have been a tremendous asset to the County, and to the departments she has served; and

WHEREAS, during her long years of service, Ebby Johnson earned the admiration and respect of her supervisors, co-workers, county departments, and the citizens of Monterey County through exemplary customer service performed in a professional and courteous manner.
