

Report on a Proposed Ordinance addressing single-use plastics and disposable food service ware

- Unincorporated Monterey County's Food Operators:
- 468 Permitted Food operations
- 143 "Brick and Mortar" Food facilities
- 143 mobile food preparation units (MFPU's)
- 182 annual temporary food vendors
- Also includes "non-profit" food operations (fund raisers)



State and Local Municipal Legislation:

City of Monterey

 Dine-IN facilities require non-disposable food service ware; take out required to be compostable/recyclable

City of Salinas

 Food vendors must provide biodegradable, compostable, or recycled disposable food service ware

City of Pacific Grove

 Dine-IN facilities require non-disposable food service ware; take out required to be BPI (Biodegradable Product Institute") certified compostable food service ware

City of Carmel-by-the-Sea

- prohibits restaurants and food vendors from providing CFC (chlorofluorocarbons) processed food packaging and polystyrene food packaging; provides that restaurants and food vendors use exclusively biodegradable, compostable, or recycled products for packaging;
- single use straws are to be provided only upon customer request; single use to-go utensils may only be provided if requested by a customer; requires all restaurants and food vendors using disposable food service ware use biodegradable, compostable (American Society of Testing and Materials certified), or recycled products



OUNTY OF MONTEREY

State of California

- SB 54 (The California Container Recycling and Litter Reduction Act) and AB 1080 (Solid Waste: packing and products), which address plastic on a large scale and not just the food industry. These pieces of legislation would require all single-use plastic packaging and products in California to be reduced or recycled by seventy-five percent (75%) by 2030.
- Assembly Bill 1162 (AB 1162: Lodging establishments: personal care products: small plastic bottles) establishes a timeline for lodging establishments to phase out small plastic bottles for personal care products.
- AB 1884 (Food Facilities: single use plastic straws) provides that a full-service restaurant shall not provide plastic straws unless requested by a consumer. This is limited to establishments that provide food on premises and where consumers are escorted to an eating area.
- The Board recently sent letters of support for AB 1080 and SB 54 to State Senator Allen and Assemblymember Gonzales; both of these bills address plastics packaging at the "upstream" manufacturer/packing point.



- State retail food code addressing single-use articles notes that "temporary" food facilities must provide single use articles (California Retail Code, Chapter 11, Section 114353).
 - This code as written would allow recyclable/compostable products to be used

Outreach Efforts/Community Engagement

- EHB reached out to survey unincorporated food facilities
 - Many already increasing use of alternative materials for single use utensils
 - Paper bags being implemented; 25 cents per bag
 - Soups may be an issue as paper containers have a limited timeframe to hold adequately
 - Overall biggest issue/concern is client/customer understanding
 - EHB informed each facility we will continue to reach out



Considerations

- -Exemptions in situations like skilled nursing for patients with compromised mobility.
- One challenge is that many compostables look like plasticware and end up in the wrong containers.
