WHEREAS, Al Scheid chose the Salinas Valley to start his vineyard business and invited his son **Scott Scheid** in 1986 to join the family business; and

WHEREAS, **Scott Scheid** met Nancy at a jazz club in 1991 and married in 1993; and

WHEREAS, **Scott and Nancy Scheid's** daughter Kira was born in 1999 and Chloe in 2001; and

WHEREAS, Scheid Family Wines currently produces and distributes, together with its family brand, Scheid Vineyards, over 500,000 cases annually comprising 60 brands to all 50 states and 14 countries; and

WHEREAS, the Scheid Family began the path to sustainable farming and winemaking long ago, have always believed that growing the highest quality wine grapes and crafting the best wines possible can only be achieved through taking care of the land, their people, and community; and

WHEREAS, a wind turbine was installed in the fall of 2017 that powers the entire winery, generates enough excess energy to power 125 homes annually and in May 2019, Scheid Family Wines was recognized with the California Green Medal Environment Award; and

WHEREAS, **Nancy Scheid** has been involved with supporting the community through multiple philanthropic organizations which include Monterey County Junior League, parent's boards at their children's school, Girl Scout leader, National Charity League Monterey Bay, The Leukemia & Lymphoma Society, Monterey Jazz Festival, American Heart Association, and the Walk to End Alzheimer's; and

WHEREAS, **Scott Scheid** is past president of the Monterey County Vintners and Growers Association, served on the California Association of Winegrape Growers, National Steinbeck Center Board of Trustees, Master Knight in the International Brotherhood of the Knights of the Vine, Monterey Chapter Cadre, Monterey County District Director for the California Wine Institute, Rabobank National Ag Advisory Board, and Monterey Jazz Festival; and

WHEREAS, **Scott and Nancy Scheid** have raised their daughters locally and taught them the value of hard work, giving back to their community; and

WHEREAS, **Scott and Nancy Scheid** have embraced our community and are proud to be able to make a difference.

NOW THEREFORE, BE IT RESOLVED, that the Monterey County Board of Supervisors, on behalf of the County and all its residents thereof, recognize **Scott and Nancy Scheid** for their
