WHEREAS, while studying at UC Berkeley, Magaly interned for then, Assemblymember Luis Alejo's district and capitol offices where she assisted with event planning and policy staffing; and

WHEREAS, Magaly Lizet Zagal was involved in a wide range of projects in my office, giving her the opportunity to really harness important skills when working with the community and local youth; and

WHEREAS, she assisted with the development and implementation of my Young Assemblymembers Program, a young leadership program geared towards high school and college students to learn about law, public policy and government. She personally developed and led the workshops in the summer of 2011 and 2013; and

WHEREAS, during these workshops, she naturally assumed a leadership role. She has also been involved in recruiting youth from the community for various community service opportunities and leadership summits put together by other organizations; and

WHEREAS, Magaly Lizet Zagal's journey at my district office did not end in Salinas. In fact, she was proactive to use her knowledge from district office affairs and apply her research skills working at my then State Capitol office in Sacramento as well; and
