WHEREAS, Medi-Cal applications will be collected and forwarded to Social Services for eligibility benefit determination, processing, and tracking of outcomes; and

WHEREAS, increased appropriations and revenues of \$208,687 in the Social Services Budget Unit 001-5010-SOC005-8262 FY 2019-20 Adopted Budget is needed for current year operations and remaining funds will be incorporated through next years' budget process; and
