FY 2019-20 Adopted Budget and the Human Resources

WHEREAS, the Health Department Clinic Services Bureau (Health Department) operates ten newly designated Federally Qualified Health Centers (FQHC); and

WHEREAS, operating FQHC clinics provides the opportunity for the County to serve the most vulnerable populations in the community with eligibility to access to federal funding under Section 330 of the Public Health Service Act for the purpose of enhancing and increasing medical service delivery to Monterey County residents; and

WHEREAS, the new FQHC clinics' designation was achieved after the County's successful application for a New Access Point Grant (NAP) through the U.S. Department of Health and Human Services; and

WHEREAS, as a result of this award, the Health Department clinics and NIDO clinic were designated as FQHC Grantees; and

WHEREAS, on November 19, 2019, the Board of Supervisors approved the transfer of management of the NIDO clinic from Natividad Medical Center (NMC) to the Health Department; and

WHEREAS, in order to fully transition the management of the NIDO clinic to the Health Department, position changes need to occur in the FY 2019-20 Health Department and Natividad's budget.

NOW, THEREFORE, the Monterey County Board of Supervisors, hereby resolved to approve the following:
