process the fact that they looked out their windows and saw all these folks throwing in a helping hand picking up a shovel and helping them remove the needed objects from their home such as appliances and get them into these dumpsters to help them move forward. It really sent a signal that Monterey County cares, so he wanted to thank those folks for stepping up and being part of our response on the ground in Chualar. He also reported that he was very lucky last weekend to attend an event at the Robinson theater in King City which is a WPA Project from the Alphabet Zoo projects of the 40's. It's a beautiful facility that is adorned with art by Joe Mora and it was created in his Pebble Beach Studio. They dedicated a brand new plaque donated by the Native Sons of the Golden West. He thanked his 8th grade teacher, Mr. Walton, who invited him. Mr. Walton is one of the two community historians who invited him to speak that day. It was an awesome ceremony that brought attention too often times an overlooked facility in Southern Monterey County.

Supervisor Mary L. Adams shared that she is thankful that things worked out as well as they did in Chualar as she knew that storm was really bad. She also drew people's attention to the many holiday things that are going on throughout the county at this point but there's one that I really want to draw people's attention to because of highlights such a special part of Monterey County and Monterey in the city itself. This is the Christmas in the Adobes which will be taking place this weekend Friday, Saturday, at all of the different adobes throughout downtown Monterey. It is a wonderful experience if you had not have had the chance to go through and see adobes decorated in the Christmas style related to the days when the adobes were first built as it's a beautiful experience. She hoped people take the opportunity to do that and there's also a celebration on Sunday at the Customs House Plaza that people can enjoy as well. She also thanked the people in our community for their support of her because on Wednesday it was the final day to file papers for other people who choose to run for election against different people. She did not have anyone file against her, so she has had 5 years of uncontested work on the behalf of people Monterey County and with her colleagues as well. Now at a later time Supervisor Adams commented on her holiday open house that will be held on December 17, 2019, from 2:00 to 4:00 p.m. in the basement of the courthouse in Monterey.

Supervisor John M. Phillips commented about North County going through the projectile case. He shared it is neat to see the community stepping up. A number of people in the community have offered to increase the reward. The CHP has been working extensively on this and it is a real difficult to get a hand on it. A lot of these types of crimes if you're there 10 seconds to late or too early then you don't have anything. It is a big concern and they have been really been fortunate that no one has been seriously injured. Next Tuesday they'll have a community outreach in his office as a holiday recognition especially to all the Commissioners who served on the various boards out there. They will be raising money for toys and food for the Castroville and Pajaro communities. Supervisor Alejo is also having a similar open house this evening at 5:00 p.m.

Supervisor Luis A. Alejo commented that he, Supervisor Adams, Supervisor Lopez and the Charles McKee, County Administrative Officer, last week, attended the California State Association, County Executive Board conference. He was able to speak on one panel and they had the State Insurance Commissioner Ricardo Lara that spoke to the Executive Board he mentioned this as he had put a moratorium on insurance companies pulling insurance policies from fire ravaged areas in our state. This is becoming a bigger issue and we are paying attention because we know we are prone to have fires too and if we had our insurance companies pulling policies from our residence that could impact us to the next time we had a fire in our County. He wanted to thank our Insurance Commissioner for doing that but there needs to be a lot more work in these rural areas that are being heavily impacted and huge enormous cost to local family trying to sustain their fire policies. He also commented that he and his office teamed up with the Clerk of the Board's office in our tree lighting ceremony. He donated our Christmas tree for the second year for the lobby. He hoped that next year our Board could fund it as a board item so that all can participate from the Board to the Community. The tree cost less than \$500 and we have the lights and decorations already but it is something nice for the County employees in this building and all the public that come. He shared that you should see all the people that come in and take photos there. We had a tree lighting, but the Clerk's office also brought in Santa and we also had the Ugly Sweater Contest. It was a real fun event with our employees in the building which is something that is really appreciated. It would be nice to perhaps institutionalize as an annual practice that the Board sponsor a tree for the public and our county employees to bring some holiday cheer into the building. Lastly, he commented on his holiday open house today after our meeting it starts from 5:00 to 7:00 p.m. They are doing a clothing drive, a winter clothing drive, a toy drive and a backpack drive. This is the second year they are doing it. They will be teaming up with the City of Salinas with Mayor Joe Gunter. Everything is donated and they also buy items and they deliver them to all the residents. They have 90 residents and two thirds are women and children who stay at their County homeless shelter. Last year they gave each child a backpack because every morning they have to get their belongings and leave. They thought it would make life a little easier to give each child their own individual backpack with school supplies. They put winter clothing items for them and they seem to really appreciate it. What many people take for granted our children staying at the shelters don't even have those basic necessities. They team up with the fire department because they don't have a red sleigh. They go deliver the items with the Salinas firefighters, so he wanted his colleagues and staff to stop by as it is important. Ultimately they are doing a good thing by raising donated items to deliver to the shelter. They will be delivering those items on the 23rd of December and everybody's welcome to join them to deliver those items.

Supervisor Jane Parker thanked everyone who came to their holiday party. It was their 11th annual open house. It was great to have county staff there, community members and, of course, the Commissioners. They have been doing a Commissioner recognition every year and one thing that's fun about that is that the Commissioners who were there get certificate of recognition, but we also have them say a sentence or two about the issues they're working on their commission. The variety of commissions that we have as part of our County operations is just such a fascinating variety and so many people have never heard of most of them so it's the really educational experience for the Commissioners themselves to hear from each other as well as the community members who are there. It was a warm and well attended event and we got really good set of contributions for the food bank account as well. She also wanted to mention that the Children's Council is accepting nominations for their Champions for Children award. They are looking for organizations that have implemented policy, programs or system changes to improve the
