The chinook salmon smolts will be tagged with Coded Wire Tags for monitoring purposes. The project is intended to mitigate the pervasive spawning habitat and loss encountered by returning adult salmon and increase the number of (adult) chinook salmon for harvest in the Monterey Bay for sport and commercial fishing.
