USE PERMIT STANDARDS

Location:


- Within Commercial Zone
- Not within 600 feet of a school, playground, youth center, or child-care center
- Records Keeping and Non-Diversion
 - Track and Trace
- Security
 - · Cameras, Safes, Guards, Protocols
- Packaging and consumer safety
 - Tested products, Permitted supply chain
- Nuisances
 - Odor, loitering, on-site consumption
- Federal Enforcement Priorities
 - Restrict Access to Youth
 - Prevent diversion

OTHER PERMITS REQUIRED

- Use of property to include commercial medical cannabis dispensary (Land Use)
 - Dispensary Business
 - Commercial Cannabis Business Permit (Section 7.90);
 - Business License (Section 7.02); and
 - State licenses.
- Businesses will be regularly inspected and audited pursuant to required licenses/entitlements.
- Property owner responsible for evicting cannabis business that does not comply (grounds for revocation of Use Permit)

SETBACK

- 1,500 feet from another Dispensary
 - No Use Permits have been approved within 1,500 feet of the site.
 - Two applications pending
- Implementation
 - Applications considered based on "application date" and "complete date"
 - Setback measured from dispensary with an approved Use Permit



APPEAL

- June 27, 2018 Planning Commission approves Use Permit (4-3)
- Appeal filed by Natalia Thurston on behalf of Bayside Dispensary, LLC (applicant on the neighboring property)
 - Contentions
 - County violated the Permit Streamlining Act for PLN170310/Villafranca
 - Unequal treatment of PLN170310/Villafranca (neighboring application) and PLN170478/Pacheco (subject application)
 - Standards for employee counts and septic system improvements
 - Responses
 - County has corrected completeness dates and has treated both applications equally
 - Difference stems from individual site conditions
