## AMENDMENT NO. 1 TO SERVICES AGREEMENT BETWEEN NETWORK CABLING SOLUTIONS, INC. AND COUNTY OF MONTEREY, THROUGH ITS INFORMATION TECHNOLOGY DEPARTMENT FOR REPAIR EXTERNAL SECURITY DOORS AND SECURITY CARD ACCESS AT THE INFORMATION TECHNOLOGY DEPARTMENT BUILDING

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on September 1, 2019 is entered into by and between the County of Monterey, on behalf of its Information Technology Department (hereinafter "COUNTY"), and Network Cabling Solutions, Inc. (hereinafter "CONTRACTOR"); (collectively, the County and CONTRACTOR are referred to as the "Parties"), with respect to the following:

## RECITALS

**WHEREAS**, the Agreement was executed for CONTRACTOR to provide repair services to external security doors and security card access at the Information Technology Department building with a term September 1, 2019 through August 31, 2020 and a total Agreement amount not to exceed \$24,950; and

**WHEREAS**, COUNTY and CONTRACTOR currently wish to amend the Agreement, adding an additional \$3,543.20, for additional costs to repair security door, for a revised not to exceed of \$28,493.20, with no change to the scope of services and no change to the term of the agreement.

## AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby amended on the terms and conditions as set forth in the Agreement, except as specifically set forth below.

- 1. Paragraph titled "PAYMENT PROVISIONS" shall be amended to the following: "County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$28,493.20."
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect.
- 3. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
- 4. This Amendment No. 1 shall be effective upon execution by both parties.
