### Energy Efficiency Financing – Historical Data



### **1993 to Present Time**

- Energy Efficiency; Water Conservation;
   Seismic Retrofit (PACE)
  - More than 35,200 projects completed; more than 22,500 additional projects in the pipeline
  - Includes more than \$884.5 million in associated financing
  - GSFA's first energy efficiency financing program utilized American Recovery and Reinvestment Act (ARRA) Funds - Partnering with CEC

# GSFA – Public Purpose



- As a JPA, Members utilize GSFA to perform common powers
- Provides for economies of scale and de-risk local capital formation efforts
- Members trust GSFA to issue debt and to develop and administer valuable programs

## GSFA – Public Purpose (Cont'd)

- Focus on programs beneficial to low/moderate income individuals and families that may not otherwise be served; Reaching a diverse population More than 50% of those participating in the housing program today are minorities.
- Ensure Housing and PACE Programs are accessible in urban, suburban and rural communities
- Support and implement economic development and job creation efforts along with municipal infrastructure finance





# GSFA Public Purpose (Cont'd)

GSFA – Giving Back to those most in need

- GSFA has provided \$3.5 million in emergency assistance to victims of past CA fires.
  - Resources were made available to assist residents with temporary and replacement housing and rebuilding efforts.



#### GSFA Affiliate Entities – Giving Back

- Implementing Human Trafficking prevention and awareness education in rural CA public schools
- Provided more than 1,300 laptops to foster youth
- Participated in financing the renovation of a 12-unit apartment complex to house homeless veterans and their families
