WHEREAS, on August 26, 2014 the Board of Supervisors approved the Scope, Cost and Schedule for the New Juvenile Hall Project 8811 (Project), with an initial total project budget of \$52,791,824; and

Offender Rehabilitative Facility Construction Funding Program.....

WHEREAS, on March 28, 2017 the Board of Supervisors approved an increase of \$5,879,467 in the Project budget to fund increased project costs, resulting in a revised Project budget of \$58,671,291; and

WHEREAS, on June 25, 2019 the Board of Supervisors approved an increase of \$320,681 in the Project budget for costs incurred above the established project contingency during Fiscal Year (FY) 2018-19, resulting in a revised Project budget of \$58,991,972; and

WHEREAS, on July 23, 2019 the Board of Supervisors approved an increase of \$590,963 in the Project budget to fund known change orders in FY 2019-20, resulting in a revised Project budget of \$59,582,935; and

WHEREAS, on November 5, 2019 the Board of Supervisors approved an increase of \$2,577,580 in the Project budget to fund known change orders in FY 2019-20 and security fencing around staff parking, resulting in a revised Project budget of \$62,150,515; and

WHEREAS, on March 17, 2020 the Board of Supervisors approved an increase of \$725,835 in the Project budget to fund additional change orders and consultant costs, resulting in a revised Project budget of \$62,886,350; and

WHEREAS, the County of Monterey has now determined that due to decreased revenue projections from COVID-19 impacts, and unanticipated cost increases and time delays, that it is not in a

financial position to fund the 120-medium-security-bed Project, with a State-approved budget of \$58,671,291 and County approved funding of \$62,886,350, and projected total cost of \$68,300,000, and; therefore, County elects to construct a smaller 80-medium-security-bed facility without onsite kitchen or laundry facilities, for an estimated total Project cost of \$61,272,032.

NOW THEREFORE BE IT RESOLVED, by the Monterey County Board of Supervisors that said Board does hereby:

- a. Approve the change in Scope, Cost and Schedule for the New Juvenile Hall, Project 8811 (Project), to reduce the Project from a 120-medium-security-bed facility to an 80-medium-security-bed facility with essential administrative space improvements based on the State of California conditional award of \$35 million, total project cost of up to \$62,886,350, and project completion date of June 2021;
- Authorize the Resource Management Agency (RMA) Director or designee to submit the revised Project Scope, Cost and Schedule to the Board of State and Community Corrections (BSCC) for approval;
- c. Authorize the Resource Management Agency (RMA) Director or designee to submit the revised Project Scope, Cost and Schedule to the California Department of Corrections and Rehabilitation (CDCR) for approval; and
- d.
