WHEREAS, for Fiscal Year (FY) 2019-20, the EGPFA has higher-than-anticipated prepaid East Garrison Community Facility District (EGCFD) tax administration from East Garrison property owners;

WHEREAS, the Resource Management Agency (RMA) needs to revise its budget projection from 23 to 55 prepaid property owners, bringing the FY 2019-20 prepaid CFD tax administration to \$15,015, leaving an estimated budgetary shortfall of \$8,736;

WHEREAS, to maintain adequate funding levels to finance and manage EGCFD prepaid tax expenditures, it is necessary to increase appropriations by \$8,736 in FY 2019-20 EGPFA Adopted Budget, Fund 180-EGCFD, Appropriation Unit RMA105, financed by Fund 180, EGPFA Unassigned Fund Balance, Balance Sheet Account 3101; and

WHEREAS, on April 29, 2020, the Monterey County Budget Committee supported the recommended action.
