## AMENDMENT NO. 1 TO AGREEMENT FOR SERVICES BETWEEN MONTEREY COUNTY WATER RESOURCES AGENCY AND MANAGEMENT PARTNERS

**THIS AMENDMENT NO. 1** to the Agreement for Services ("Agreement") between the Monterey County Water Resources Agency (hereinafter, "Agency") and Management Partners (hereinafter, "CONTRACTOR") is hereby entered into between the Agency and the CONTRACTOR (collectively referred to as the "Parties").

**WHEREAS,** CONTRACTOR and Agency entered the Agreement on June 14, 2018 (hereinafter, "Agreement"); and

**WHEREAS**, the Parties wish to amend the Agreement to extend the term to June 30, 2021 with an associated dollar amount increase of \$10,000.00 to continue to provide services identified in the Agreement.

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

- 1. Amend Section 1, "<u>Employment of Contractor</u>" to include **Exhibit A-Revised**, attached hereto.
- 2. Amend Section 2, "<u>Term of Agreement</u>", to read as follows:

The term of this Agreement shall begin upon execution of this Agreement by CONTRACTOR and Agency, and will terminate on **June 30, 2021**, unless earlier terminated as provided hereto.

3. Amend Section 3, "Payments to CONTRACTOR; maximum liability", to read as follows:

Subject to the limitations set forth herein, Agency shall pay to CONTRACTOR the amounts provided in **Exhibit B-Revised**, attached hereto. The maximum amount payable to CONTRACTOR under this contract is One Hundred Seven Thousand and Three Hundred dollars (\$107,300.00).

- 4. All other terms and conditions of the Agreement remain unchanged and in full force.
- 5. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
