Adopt a Resolution approving the Fiscal Year 2020-21 Budget for the Successor Housing Agency to the Redevelopment Agency of the County of Monterey.

### RECOMMENDATION:

It is recommended that the Board of Supervisors adopt a Resolution approving the Fiscal Year 2020-21 Budget for the Successor Housing Agency to the Redevelopment Agency of the County of Monterey.

### SUMMARY/DISCUSSION:

The County Administrative Office recommends that the Board of Supervisors approve and adopt the Fiscal Year (FY) 2020-21 Budget for the Successor Housing Agency to the Redevelopment Agency of the County of Monterey (Successor Agency). This budget is unchanged from the FY 2020-21 Recommended Budget as presented and received by the Board during Budget Hearings on June 1-2, 2020. The FY 2020-21 Budget for the Successor Agency includes \$1,394,100 in total appropriations, offset by estimated revenue of \$219,200 and \$1,174,900 in unreserved fund balance.

### OTHER AGENCY INVOLVEMENT:

The County Administrative Office prepared the Successor Agency FY 2020-21 Adopted Budget Resolution reflecting Board approval of the FY 2020-21 Recommended Budget as presented on June 1-2, 2020.

### FINANCING:

The Successor Agency FY 2020-21 Adopted Budget Resolution reflecting Board approval by reference of the FY 2020-21 Recommended Budget as presented on June 1-2, 2020 represents a balanced budget and meets all requirements for adoption.
