UNEMPLOYMENT COMPENSATION SERVICES MODEL AGREEMENT PARTICIPATION AGREEMENT

County of Monterey, a political subdivision of the State of California, ("Participating County") and TALX Corporation (a provider of Equifax Workforce Solutions), a Missouri corporation, ("EWS") agree that Participating County shall receive Services under the provisions of the Unemployment Compensation Services Model Agreement with an Effective Date of July 1, 2016, by and between TALX Corporation and the County of Personnel Administrators Association of California ("CPAAC"), (the "Agreement") which provisions are incorporated herein by reference and set forth in full. This Participation Agreement shall automatically renew for three (3) successive one (1)-year terms ("Successive Terms") unless either party provides the other with written notice of termination at least ninety (90) days prior to the end of the then current term before terminating the Participation Agreement.
- 2) **Termination.** Either party may terminate this Participation Agreement if the other party has materially breached the Agreement, provided that the party claiming breach must give the other party at least thirty (30) days prior written notice in which to cure the breach before terminating this Participation Agreement.
