I would like to request for a public hearing in regards to the Director of Planning of the County of Monterey Resource Management Agency, State of California's pending administrative design approval "to allow a solid wood fence along the property, from 3 feet in height to 4 feet". My property (39 Llano Ave.) is adjacent to the project's property and directly impacts my property dynamics and characteristics in the way of security, safety, and aesthetics. I do not agree with the request to allow a solid wood fence along the property, from 3 feet in height to 4 feet and demand that planning department uphold the prescribed recommendations of the Spreckels Neighborhood Design Review Committee, which was drafted after the meeting in August 21, 2019.

- · Fence needs to change to open pattern
- Fence needs to be no taller than 4 feet
- 6' fence needs to be in backyard not all the way to the street

The town of Spreckels has guidelines for fence designs due to its historical nature, where even the newest homes which were constructed in 2008 (Standard Pacific) maintained and abided by. Concerns of safety and aesthetics consistent with the towns longstanding design guidelines as referenced in design guideline book S2.1 and S3.1 need to be enforced and not wavered upon to continue the longstanding tradition and uniqueness of the town's architecture as well as safety for its residents and visitors.

County permit office also acknowledged that the original building permit that was approved should not have been approved with the outdoor fence design, which should have been submitted and reviewed separately. Note that the current fence was erected despite the county's direction to cease and desist construction until the property owners could resubmit plans for review before proceeding with construction. The property owner's willful decision to proceed with the erection of the fence against the County's direction was their prerogative and should not be overlooked with the pending design approval.
