AMENDMENT NO. 2 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN COUNTY OF MONTEREY AND KIMLEY-HORN AND ASSOCIATES, INC.

THIS AMENDMENT NO. 2 to Professional Services Agreement No. A-13277 between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Kimley-Horn and Associates, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Professional Services Agreement No. A-13277 with County on September 9, 2016 (hereinafter, "Agreement") to provide on-call civil engineering services for transportation projects located in Monterey County, Request for Qualifications (RFQ) #1601 (hereinafter, "services") through August 31, 2019 with the option to extend the Agreement for two (2) additional one (1) year period(s) for an amount not to exceed \$300,000; and

WHEREAS, Agreement was amended by the Parties on August 28, 2019 (hereinafter, "Amendment No. 1") to update the Indemnification for Design Professional Services Claims and to extend the term for one (1) additional year through August 31, 2020 with no increase in the not to exceed amount; and

WHEREAS, the County has a continued need for services; and

WHEREAS, additional time and funding are necessary to allow CONTRACTOR to continue to provide the services required by the County; and

WHEREAS, the Parties wish to further amend the Agreement to extend the term for one (1) additional year to August 31, 2021 and to increase the amount by \$300,000 for a total not to exceed \$600,000 to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 2.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend the second sentence of Paragraph 2 "Payments by County", to read as follows:

The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of <u>\$600,000</u>.

2. Amend the first sentence of Paragraph 3, "Term of Agreement", to read as follows:

The term of this Agreement is from September 1, 2016 to August 31, 2021 unless sooner terminated pursuant to the terms of this Agreement.

3. In all places within the Agreement, any reference to County's email address of <u>RMA-Finance-AP-GP@co.monterey.ca.us</u> for invoicing, is hereby replaced with <u>RMA-Finance-AP@co.monterey.ca.us</u>.
