WHEREAS, Laura Lienk is an active Applied Environmental Science, Biology, and Chemistry lecturer and enthusiastic volunteer and director of Return of the Natives who seeks to connect citizens, both locals and visitors, to the vast array of native plants and animals that call the Monterey Bay home; and

WHEREAS, Laura Lienk and Return of the Natives assist in the county's native plant greenhouse and garden and sow seeds, transplant, weed, water, and care for native plants grown for habitat restoration; and

WHEREAS, Laura Lienk and Return of the Natives community events are held on most Saturdays throughout the year to restore native habitat and cleanup our green spaces in many sites including Fort Ord Dunes and Fort Ord National Monument, CSUMB, Monterey State Beach, and Creeks of Salinas; and

WHEREAS, Return of the Natives volunteers continue to clean up and restore our creeks, rivers, and streams, improving not only our watersheds and marine sanctuary but quality of life for all who live in the communities across Monterey County; and

WHEREAS, many of Return of the Natives restoration sites are located within the Bureau of Land Management Fort Ord Public Lands, the Creeks of Salinas, California State Parks, and Monterey Peninsula Regional Park District lands; and

WHEREAS, Laura Lienk and Return of the Natives work with the Service Learning department at California State University Monterey Bay to provide meaningful opportunities to help achieve the goal of *bringing people closer to nature and nature closer to people* and encourages CSUMB students to a take a leadership role while exercising the skills and ideas that they have been learning in their classes; and

WHEREAS, With the help of Return of the Natives' educators, student staff and volunteers, native plant gardens were installed at 11 Monterey Peninsula Unified School District elementary schools and annually, Return of the Natives adds to this list, and assists where they can; and

WHEREAS, Laura Lienk and Return of the Natives offer educational programs with class experiences including topics such as plastic in the ocean, native plants and animals and watershed science in addition to field trip experiences and activities include bird watching, trash cleanup and planting.
