AMENDMENT #1 TO PROFESSIONAL SERVICES AGREEMENT COUNTY OF MONTEREY & TMD CREATIVE

THIS AMENDMENT is made to the PROFESSIONAL SERVICE AGREEMENT for the provisions described in Exhibit A and between TMD CREATIVE hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, Agreement was amended by the Parties on August 25, 2020 to increase the Agreement amount by \$349,000,000 to which resulted in a total not to exceed amount of \$409,000 with a term extension to December 31, 2020; and

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 2., "PAYMENTS BY THE COUNTY" shall be amended by removing, "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$60,000" and replacing it with "The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed \$409,000 with a term extension to December 31, 2020."
- 2. EXHIBIT A Scope of Services shall remain the same.
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 4. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on August 25, 2020.
