WHEREAS, the dissolution of the Fort Ord Reuse Authority (FORA) resulted in the transfer of responsibilities of the Veterans Issues Advisory Committee (VIAC) to the County of Monterey - Military & Veterans Affairs Office (MVAO).

WHEREAS, the Fort Ord Reuse Authority (FORA) has approved funding for a 3-year term of 1 Full Time Equivalent (FTE) that will staff the Veterans Issues Advisory Committee (VIAC) and be housed in the Military & Veterans Affairs Office (MVAO);

WHEREAS, the County of Monterey has received one-time funding of \$346,053 from FORA for the benefit of the Military & Veterans Affairs Office in FY 2019-20 and will be moved to BSA 3042 Restricted Fund Balance-General for FY 2020-21;

WHEREAS, the new position will be classified as a Management Analyst I (MA I) and will serve the Veteran Community through networking and collaborating with all post FORA municipalities, agencies and organizations (public, private, non-profit and higher education);

WHEREAS, the MA I will become fully accredited to process claims with the U.S. Department of Veterans Affairs and will provide veteran claims, benefits and education to Military, Veterans and Dependents;

WHEREAS, the MA I will monitor, track and champion State and federal Legislation that would benefit the Veterans and Military community of Monterey County;

WHEREAS, the Department of Social Services / Military & Veterans Affairs Office has determined the need to add one (1) Management Analyst I (MA I) to perform all new responsibilities acquired through the dissolution of FORA; and

WHEREAS, the Department / Office will require an increase in appropriations in FY 2020-21 of \$115,351 which will be funded by actual expenditures thru a transfer of BSA 3042 Restricted Fund Balance-General.
