AMENDMENT NO. 1 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY & L3HARRIS TECHNOLOGIES, INC.

THIS AMENDMENT No. 1 is made to the AGREEMENT for NGEN path diversity from La Mesa Communications site, by and between L3Harris Corporation Technologies, Inc. hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY."

WHEREAS, the County and CONTRACTOR entered into an agreement on June 1, 2020, by which CONTRACTOR is to provide NGEN path diversity services for the County's La Mesa communications site in the amount of \$71,644.70; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to add additional funding in the amount of \$1,466.15 to pay taxes on materials used, for a total contract amount not to exceed \$73,110.85;

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. **Paragraph 2.0, Payment Provisions** shall be amended to the following, "County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$73,110.85".
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT No. 1 and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of this AMENDMENT No. 1 shall be attached to the original AGREEMENT dated June 1, 2020.
