Environmental mitigation measures MM-BIO-3.2, MM-BIO-7.1, MM-BIO-8.1, MM-BIO-8.2, MM-BIO-8.3, MM-BIO-10.2, MM-BIO-10.4, MM-BIO-15.1, MM-BIO-15.2, MM-BIO-16.2, MM-BIO-16.3 are to be included in the services provided by the CONTRACTOR. The CONTRACTOR shall provide the County with a report documenting the results of each survey.

3. On page 10, Item 8.1, replace the entire paragraph with the following:

"Submittal Identification Requirements: ALL SUBMITTALS MAILED OR DELIVERED CONTAINING PROPOSAL MUST BE SEALED AND BEAR ON THE OUTSIDE, PROMINENTLY DISPLAYED IN THE LOWER LEFT CORNER: THE SOLICITATION NUMBER RFP #10757 and CONTRACTOR'S COMPANY NAME. CONTRACTOR MUST INCLUDE ONE (1) ORIGINAL HARD COPY AND ONE (1) CD OR THUMB DRIVE WITH PDF FILES OF SUBMITTAL MATERIALS; AND ONE (1) ORIGINAL ATTACHMENT I IN A SEPARATE SEALED ENVELOPE."
