All obligations under the Sanction Agreement shall be performed directly by County.
- 2. Further to the letter dated September 29, 2020, copy attached, from IMSA President, John Doonan, to John Narigi, President and General Manager of WeatherTech Raceway Laguna Seca, and approved by Lavonne Chin on behalf of County of Monterey, the 2020 Hyundai Monterey Sports Car Championship was rescheduled as follows due to the state and county restrictions imposed due to the COVID-19 pandemic and no spectators being allowed.

New Dates:

October 30 – November 1, 2020

3. Section 3A shall be amended as follows for the 2020 Sanction Fee, which as of this date has been paid:

- 4. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
