# AMENDMENT NO. 2 TO SERVICES AGREEMENT BETWEEN EVERBRIDGE, INC. AND NATIVIDAD MEDICAL CENTER CRITICAL EVENT MANAGEMENT SOFTWARE SERVICES

This Amendment No. 2 to the Services Agreement ("Agreement") which was effective on January 30, 2018 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Everbridge, Inc. (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

#### RECITALS

WHEREAS, the Agreement was executed for critical event management software services with a term January 30, 2018 through January 29, 2020 and a total Agreement amount not to exceed \$62,264; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on November 22, 2019 via Amendment No. 1 to extend the term for an additional two (2) year period through January 29, 2022 to allow for services to continue with a \$65,378 increase for the added services and a total Agreement amount not to exceed \$127,642; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement with additions to the original scope of work attached hereto as "Exhibit A-2 per Amendment No. 2", with a \$6,500 increase for the added services and a total Agreement amount not to exceed \$134,142.

#### **AGREEMENT**

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Amendment No. 1 incorporated herein by this reference, except as specifically set forth below.

- 1. Section 2 titled, "PAYMENTS BY NMC", las sentence shall be amended to the following: "The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$134,142."
- 2. Section 4 titled, "ADDITIONAL PROVISIONS/EXHIBITS" shall be amended to the following: "The following attached exhibits are incorporated herein by reference and constitute a part of this Agreement:

- 3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement and in Amendment No. 1.

- 5. This Amendment No. 2 shall be effective when signed by both parties.
