COMMITTEE	PURPOSE
<p><b>Alternative Energy and Environment Committee</b> <i>Meets bi-monthly - 4<sup>th</sup> Thursday</i> <a href="#">2021 AEE Calendar</a></p>	<p>Reviews and makes recommendations to the Board of Supervisors concerning policies and action programs for long-term environmental sustainability in the County.</p>
<p><b>Budget Committee</b> <i>Meets monthly - last Wednesday</i> <a href="#">2021 BC Calendar</a></p>	<p>Provides ongoing oversight of the County budget, and in this capacity to bring those items of significant impact thereto to the attention of the full Board of Supervisors for appropriate consideration and action as warranted.</p>
<p><b>Cannabis Committee</b> <i>Meets monthly - 3<sup>rd</sup> Wednesday</i> <a href="#">2021 CC Calendar</a></p>	<p>Provides ongoing oversight of the County Cannabis Program, which manages commercial cannabis operations through coordination and collaboration with County departments to address regulation, policy, enforcement, education and protection of health and safety.</p>
<p><b>Capital Improvement Committee</b> <i>Meets monthly - 2<sup>nd</sup> Monday</i> <a href="#">2021 CIC Calendar</a></p>	<p>Reviews and makes recommendations to the Board of Supervisors on capital projects (including the 5-year Capital Improvement Program and Job Order Contracting), expenditures, leases, and issues affecting County facilities and lands. Provides budget and schedule oversight on capital projects, and if necessary, recommends corrective action to the Board of Supervisors and/or the County Administrative Office.</p>
<p><b>Economic Opportunity Committee</b> <i>Meeting dates TBD</i></p>	<p>Provides recommendations to the Board of Supervisors on economic development policies, programs and activities to ensure a Countywide perspective in support of a diversified economy, higher paying jobs and an expanded revenue base for local government services.</p>
<p><b>Equal Opportunity Committee</b> <i>Meets quarterly – dates TBD</i></p>	<p>Reviews and makes recommendations to the Board of Supervisors on matters brought forward by the Civil Rights Officer.</p>
<p><b>Health, Housing and Human Services Committee</b> <i>Meets quarterly - 3<sup>rd</sup> Thursday</i> <a href="#">2021 HHHSC Calendar</a></p>	<p>Provides recommendations to the Board of Supervisors to reduce regional, socio-economic inequities in health care outcomes. Improve health outcomes through health and wellness promotion and access to top quality healthcare. Advocate for a sufficient allocation of funds from the state and federal governments that will enable the County to carry out its authorized healthcare programs.</p>

<b>Human Resources Committee</b> <i>Meets quarterly – dates TBD</i>	Reviews and makes recommendations to the Board of Supervisors on short and long-term human resource initiatives.
<b>Legislative Committee</b> <i>Meets monthly - 2<sup>nd</sup> Monday</i> <a href="#"><u>2021 LC Calendar</u></a>	Reviews and makes recommendations to the Board of Supervisors regarding advocacy on state and federal legislative, budgetary, administrative, regulatory and policy making initiatives. Ensures County leaders are apprised of evolving state and federal initiatives impacting the County and its residents. Directs the activities of the Board’s Legislative Program and Strategic Grant Services Program.
<b>Monterey Urban County Standing Committee</b> <i>Meeting dates TBD</i>	Reviews and recommends to the Board of Supervisors Community Development Block Grant Program funding recommendations.
<b>Water Resources Agency Joint Board Leadership Committee</b> <i>Meeting dates TBD</i>	Foster coordination and communication between the Water Resources Agency's Board of Directors and the Monterey County Board of Supervisors.
