WHEREAS, currently, the first-step salary rates of four County classifications fall below the new State minimum wage; and

WHEREAS, a salary adjustment to the Community Service Aide II is recommended to prevent compaction with the Community Service Aide I classification; and

WHEREAS, the actions require the Personnel Policies and Practices Resolution No. 98-394 Appendix A be amended; NOW, THEREFORE,
