**NOTICE IS HEREBY GIVEN** that pursuant to Monterey County Water Resources Agency Ordinance No. 2974, the Board of Supervisors of the Monterey County Water Resources Agency on behalf of Zone 17 has elected to collect benefit assessments to cover costs not otherwise offset by other revenue for the Fiscal Year 2021-22 on the tax roll in the same manner as general taxes, and has caused to be filed with its Clerk a written report containing a description of each parcel of real property in Zone 17, and the amount of such benefit assessment on each property for Fiscal Year 2021-22 for each such parcel. This notice is made pursuant to California Government Code section 6066.
