AMENDMENT NO. 4 TO AGREEMENT BETWEEN COUNTY OF MONTEREY AND ERGOVERA ERGONOMIC CONSULTING

THIS AMENDMENT is made to the AGREEMENT for the provision of ergonomic analysis, training and consulting services for the office and industrial environments by and between Deidre Rogers-Smallman dba Ergovera, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY".

WHEREAS, the COUNTY and the CONTRACTOR entered into the original AGREEMENT on September 14, 2017; and

WHEREAS, the COUNTY and CONTRACTOR amended the AGREEMENT, to extend the term by one year through August 31, 2019; and increased the agreement by \$80,000, from \$100,000, for a total amount not to exceed the sum of \$180,000; and

WHEREAS, the COUNTY and CONTRACTOR further amended the AGREEMENT, to extend the term through March 31, 2020, with no increase in in value; and

WHEREAS, the COUNTY and CONTRACTOR hereby wish to renew and amend the AGREEMENT, to extend the term by nine months through December 31, 2020 and increase the agreement by \$40,000, from \$180,000 for a total amount not to exceed the sum of \$220,000; and

WHEREAS, the COUNTY and CONTRACTOR hereby wish to renew and amend the AGREEMENT, to extend the term by nine months through June 30, 2021 and increase the agreement by \$50,000, from \$220,000 for a total amount not to exceed the sum of \$270,000;

NOW THEREFORE,

The COUNTY and CONTRACTOR hereby agree to renew and amend the AGREEMENT as follows:

- 1. Section 3, "TERM OF AGREEMENT", Subsection 3.1, shall be amended to state: "The term of the AGREEMENT shall be effective September 1, 2017 through and including June 30, 2021."
- 2. Section 4, "COMPENSATION AND PAYMENTS", Subsection 4.1, is amended to read "AGREEMENT is not to exceed \$270,000 during the term of the AGREEMENT."
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect, as set forth in the AGREEMENT.
- 4. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the COUNTY on September 14, 2017.
