AMENDMENT #1 TO AGREEMENT COUNTY OF MONTEREY AND McCUNE AUDIO VIDEO LIGHTING

THIS AMENDMENT #1 is made to the AGREEMENT (Agreement ID: 10/15/20-6/30/21) for the provision of public announcement communication and corner worker staff direct communication for events and track rentals in the **County of Monterey Standard Agreement** by and between **McCUNE AUDIO VIDEO LIGHTING**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County"; and

WHEREAS, the County executed the original AGREEMENT on October 22, 2020; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to reflect an amendment to the County of Monterey Standard Agreement McCune Audio Video Lighting and Exhibit A "Scope of Services".

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 2.0 "PAYMENT PROVISIONS" shall be amended by removing "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$60,000.00" and replacing it with "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$179,000.00".
- 2. Section 3.01 "TERM OF AGREEMENT", shall be amended by removing "The term of this Agreement is from October 15, 2020 to June 30, 2021..." and replacing it with "The term of this Agreement is from October 15, 2020 to December 31, 2021...".
- 3. Exhibit-A, Article II, Section 2.11 to be amended to include the following additional fullservice 2021 events at the price noted:
