The Monterey County IDEMIA Automated Fingerprint Identification System (AFIS) is currently hosted onsite at the Monterey County Sheriff's Office. IDEMIA owns the software and system design and serves as the sole developer and provider of this solution.

The proposed IDEMIA Multi-Biometric Identification System (MBIS) is specifically designed to migrate the existing Monterey County Sheriff's Office AFIS from an on-premises solution to the Microsoft Azure Government Cloud.

As the manufacturer of the existing Monterey County AFIS and associated software applications, only IDEMIA can provide a Cloud-based MBIS solution that uses compatible software processing and interactive messaging that is tailored to fit the Monterey County Sheriff's Office public security environment. These devices use a proprietary software application that integrates seamlessly with the patented IDEMIA AFIS solution. In addition, IDEMIA is the only AFIS vendor currently offering a production AFIS solution in the Microsoft Azure Government Cloud, which is where the Monterey County Sheriff's Office has elected to host their upgraded system.

IDEMIA does not have other sales channels, partners or resellers. The proposed solution can only be procured and implemented directly from IDEMIA. As the manufacturer of the existing Monterey County Sheriff's Office AFIS, software applications, and LiveScan Fingerprint System, only IDEMIA can provide the required software and support for a fully integrated Cloud-based MBIS upgrade solution.

b) What are the unique performance features of the product/brand requested that are not available in any other product/brand? For Services: what unique qualifications, rights, and licenses does the vendor possess to qualify as a sole source/brand request?

IDEMIA MBIS is the only Cloud Hosted System for Biometrics approved in California by the Department of Justice. In addition, this system does not require refreshing of hardware which reaches end of live and includes all version (major/minor) upgrades along with keeping in alignment with legal requirements.

c) Why are these specific features/qualifications required?

Having a robust cloud based system always in compliance with the California Department of Justice reduces county liability. This system is capable of processing and reading historical identity records from the local repository. This system is a plug and play system scalable to law enforcement solution which will support future growth into new forms of law enforcement identity which include (latent, iris, fingerprint, card readers, etc) and provides reporting features required for DOJ reporting.

d) What other products/services have been examined and/or rejected?

IDEMIA is the only AFIS vendor currently offering a production AFIS solution in the Microsoft Azure Government Cloud, which is where the Monterey County Sheriff's Office has elected to host their upgraded system.

There are no other California Dept of Justice Cloud evergreen systems that provide complete high availability and redundancy. All other systems would be on-premise and would not be plug-n-play and would require hardware updates which are costly.

e) Why are other sources providing like goods or services unacceptable (please give a full meaningful explanation)?

None of the other vendors could provide a complete cloud based scalable evergreen solution which included high availability, redundancy, security, encryption, scalability with an uptime of 99.9%. The alternative would be an onpremise solution which would not be plug & play and would reach end-of-life when newer operating systems and changes in regulations where released. To have an on-premise solution with high availability and redundancy would be twice the cost.

- f) What are the unique performance features REQUIRED (not merely preferred), and how would your requirement be inhibited without this particular item or service?
