Resolution Commending **Detective Bryan “Bubba” Clester**
upon his retirement from 25½ years of public service
with the Monterey County Sheriff’s Office

WHEREAS, Detective Bryan Clester was born in Anaheim CA, and was raised along with his two sisters, by his parents Cliff and Carolyn Clester; and

WHEREAS, Detective Bryan Clester served in the United States Marine Corps from 1989 to 1993 serving in a Raider Company, and in December of 1992, his unit was involved in Operation Restore Hope which conducted operations in war-torn Somalia to help stop a famine; and

WHEREAS, upon being honorably discharged from the Marine Corps, **Detective Bryan Clester** worked as a high school football coach while putting himself through the police academy on nights and weekends; and

WHEREAS, upon graduating from the police academy, **Detective Bryan Clester** was hired by the Monterey County Sheriff’s Office and in 1995 began his career working in the jail; in 1998 he transferred to the patrol division, and from 2003 to 2009 was assigned to the Special Enforcement Detail (S.E.D.); and

WHEREAS, Detective Bryan Clester received the Oath of Office from Sheriff Norm Hicks on November 25, 1995, and over his career, served during the terms of Sheriff Gordon Sonne, Sheriff Mike Kanalakakis, Sheriff Scott Miller, and Sheriff Steve Bernal; and

WHEREAS, during his time in Special Enforcement Detail, **Detective Bryan Clester** had the opportunity to experience many different assignments to include working on an FBI Task Force, Dignitary Protection Details, Gang Investigations, and many Monterey County Special Events; and

WHEREAS, from 1999 to 2009, during his time in the Operations Division, **Detective Bryan Clester** served on the department SWAT Team, and three of those years he served as one of the Teams Snipers; and

WHEREAS, in 2009 **Detective Bryan Clester** was promoted to detective, where he worked in the Narcotics, Coroners, Property Crimes, and Agricultural Crime Units; and

WHEREAS, Detective Bryan Clester has assisted in many local, state, and federal law enforcement agencies and has received letters of appreciation from staff, citizens, and law enforcement agencies; and

WHEREAS, Detective Bryan Clester had the great experience of working with many of the finest law enforcement professionals within MCSO and outside agencies as well; and

WHEREAS, Detective Bryan Clester has been married to his wife of 24 years, Kim and they have 2 children, CJ, and Brenna.
