AMENDMENT NO. 1 TO AGREEMENT BY & BETWEEN COUNTY OF MONTEREY

THIS Amendment No. 1 is made to the Agreement by and between the Mandel Gisnet Center for Conflict Management, a 501 (c)(3) private non-profit corporation, a division of the Monterey College of Law, ("CONTRACTOR"), and the County of Monterey, a political subdivision of the State of California ("County").

WHEREAS, County and CONTRACTOR entered into an Agreement not to exceed \$50,000 on March 22, 2019 for administrative law judge services for administrative hearings related to the Environmental Health Bureau; and

WHEREAS, County and CONTRACTOR wish to amend the Agreement via Amendment No. 1 to extend the term through June 30, 2021.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the Agreement in the following manner:

- Section 3, "TERM OF AGREEMENT", is amended to read as follows at 3.01: "The term of this Agreement is from March 22, 2019 through June 30, 2021 unless sooner terminated pursuant to the terms of this Agreement", which replaces "The term of this Agreement is from May 22, 2019 through and including June 30, 2020 unless sooner terminated pursuant to the terms of this Agreement."
- Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect.
- A copy of this Amendment No. 1 shall be attached to the Agreement and shall be incorporated therein as if fully set forth in the Agreement.
- 4. The recitals to this Amendment No. 1 are hereby incorporated by this reference.
