## AMENDMENT NO. 2 OF AGREEMENT BETWEEN THE COUNTY OF MONTEREY and SALINAS VALLEY FORD SALES, INC. dba SALINAS COLLISION REPAIR (RFQ#10338 Auto Body Repair Services)

WHEREAS, SALINAS VALLEY FORD SALES, INC. dba SALINAS COLLISION REPAIR, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY" previously entered into an agreement dated *June 10*, 2013, for the provision of auto body repair services ("AGREEMENT"); and

WHEREAS, the term of the agreements from execution of the Agreement through and including August 31, 2015;

WHEREAS, the AMENDMENT #1 to the AGREEMENT was approved on July 6, 2015 to reflect the County's exercise of the option to extend for one additional year to August 31, 2016; and

WHEREAS, the AGREEMENT expired pursuant to its terms on August 31, 2016; and

WHEREAS, the RENEWAL AND AMENDMENT #1 to the AGREEMENT was approved on *November 22, 2016* to extend the term of the renewed AGREEMENT through and including *August 31, 2018*; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to extend the term of the agreement through and including *February 28, 2019*.

**NOW THEREFORE,** for valuable consideration, the sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

- 1. Section 3.1 "TERM OF AGREEMENT" shall be amended by removing "The term of this Agreement is from signing of Agreement through and including *August 31, 2018*.", and replacing it with "The term of this Agreement is from signing of Agreement through and including *February 28, 2019*."
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT NO. 2 TO AGREEMENT (RFQ#10338), and shall continue in full force and effect as set forth in the AGREEMENT;
- 3. A copy of this AMENDMENT NO. 2 shall be attached to the original AGREEMENT dated *June 10, 2013.*
