"Addressing the Digital Divide" Referral

- Collaborative efforts to address the digital divide in partnership with local schools, cities, and community partners;
- Advocate with FCC to regulate broadband access as a utility;
- Request and sponsor legislation for a universal broadband bond to be placed on the 2022 election ballot;
- A county-wide community survey on digital divide and affordable internet service;

Summary of ITD Collaborative Efforts

- Worked with CCBC, MBEP and proposed community broadband projects to Board on June 2, 2021
 - a) Board approved \$1.9 million in ARPA funds for FY 21-22;
 - b) Working with County Counsel to identify the appropriate mechanism to distribute funds equitably to qualified partners;
 - c) RFP to be released in July 2021;

 Regional broadband JPA discussions will be covered in a separate report and presentation in response to Board referral #2021.08

- Public Wi-Fi implementation
 - a) 24 County buildings to be equipped with public Wi-Fi that will benefit nearby County residents within 328 feet beyond building perimeter;
 - b) Most Library sites already have external public Wi-Fi. Public safety sites will be excluded;
 - c) Expected completion date around September 2021;

- Emergency Broadband Benefit Program (EBB)
 - Media briefing on April 21, 2021;
 - Board presentation on April 27, 2021;
 - "How to" guide published on County web site;

- "Dig Once" policy discussion with Public Works
 - a) Adopt a "Dig Once" policy as a County ordinance or resolution;
 - Will reduce the cost of building out internet access
 - Many municipal governments already doing it, including Salinas
 - b) Public Works to decide on ordinance versus resolution;
 - c) ITD to share other cities' operation practices;

- Broadband strategic plan, RCRC grant application letter of support and MOU participation
 - a) Letter of support submitted to RCRC;
 - b) Future participation in the RCRC MOU for a County-wide broadband strategic plan development grant;

- Broadband development updates from providers
 - a) Inquiry sent to Charter, AT&T and Comcast on April 2, 2021;
 - b) Received updates from Charter Communications and AT&T;

Network upgrades completed for Laguna Seca area in November 2020

Carmel Highland upgrade expected to complete in July 2021

Fiber is available around Post Ranch in Big Sur area

Legislative Updates

- In November 2019, ITD provided public comments with letter of support to California Broadband Council in support of State Broadband Action
 Plan and advocate with FCC to regulate broadband access as a utility;
- State budget includes a \$6 billion for broadband improvement pending more details;
 - \$3.75 billion for a statewide open-access middle-mile network
 - \$2 billion for last-mile projects
