### RECOMMENDATION:

It is recommended that the Board of Supervisors:

## **SUMMARY/DISCUSSION**:

The Law Office of Kelly S. Wachs, P.C, assists the County of Monterey in navigating the complex employment-based immigration process to accomplish its visa goals. Located in Aptos, California, the law firm provides County departments with obtaining for its employees temporary work visas or visas for permanent residence in the United States. IT seeks the law firm's assistance with H-1B visas and EB visas for permanent residence.

County Counsel has reviewed and approved this Agreement as to legal form.

The cost for this agreement is \$30,000, of which \$30,000 is included in the Approved Budget for the
