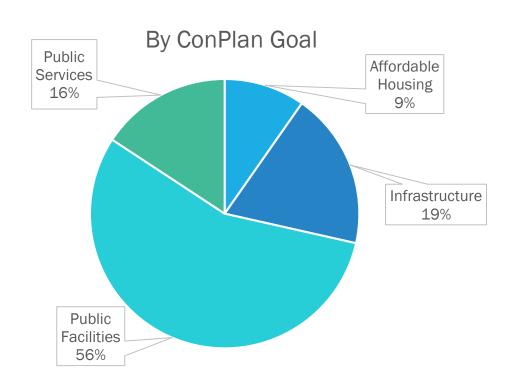

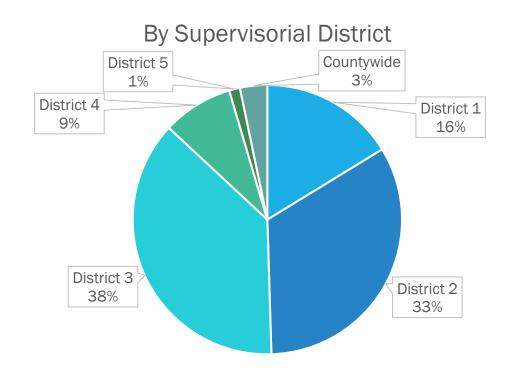
URBAN COUNTY EXPENDITURES - 2013-2022

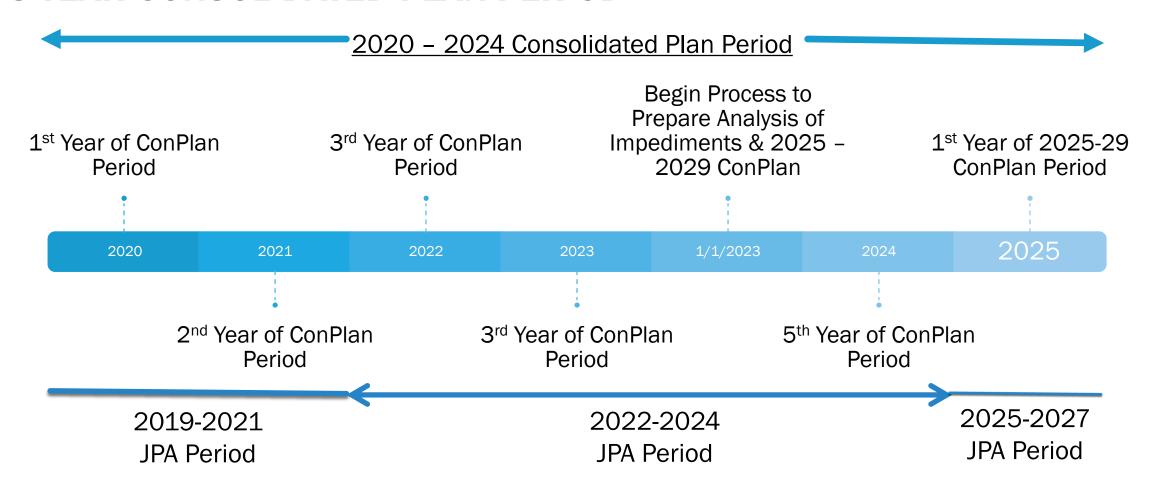




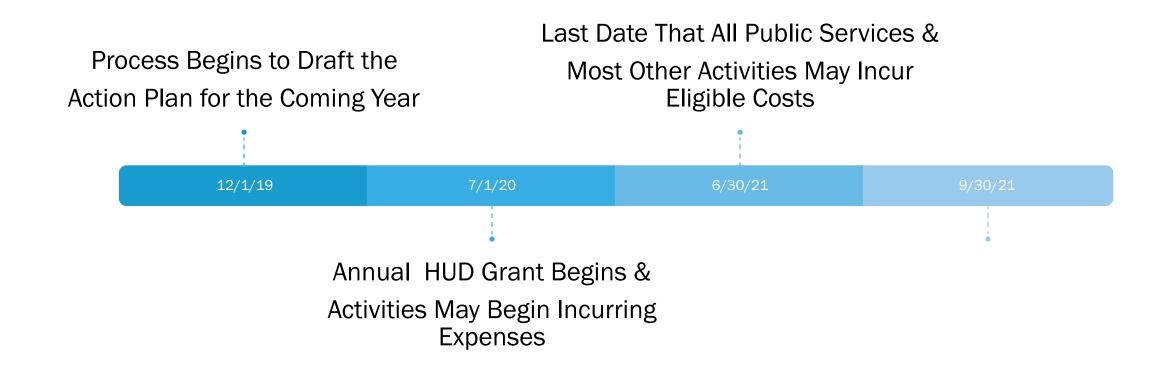

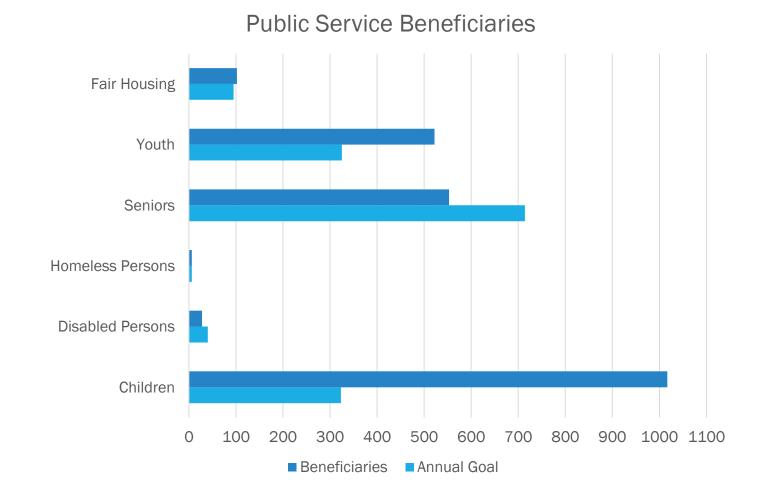
