NOTICE IS HEREBY GIVEN that on Tuesday, October 26, 2021, a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986 (the "Code") and the Treasury Regulations thereunder will be held with respect to the proposed issuance by the California Statewide Communities Development Authority of "qualified 501(c)(3) bonds," as defined in Section 145 of the Code, in one or more series pursuant to a plan of financing, in an amount not to exceed \$165,000,000 (the "Bonds"). Proceeds of the Bonds are expected to be used by Montage Health ("Montage"), a California non-profit public benefit corporation and an organization described in Section 501(c)(3) of the Code, and Community Hospital of the Monterey Peninsula ("CHOMP"), a California nonprofit public benefit corporation and an organization described in Section 501(c)(3) of the Code, of which Montage is the sole member, (i) to finance and/or refinance various healthcare-related capital improvements, including the acquisition, construction, renovation and remodeling of certain real property and the purchasing and installation of certain equipment, for Montage and/or CHOMP, and (ii) to pay costs of issuing the Bonds.
