NOTICE OF PUBLIC HEARING NOTICE IS HEREBY GIVEN that on Tuesday, October 26, 2021, a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986 will be held with resect to the proceed with respect to the proposed issuance by the California Municipal Finance Authority (the "Authority") of its revenue bonds in one or more series in an amount not to exceed \$30,000,000 (the "Bonds"), including but not limited to revenue bonds issued as part of a plan to finance the acquisition, construction, improvement and equipping of a 66-unit affordable rental housing facility for low-income tenants (the "Project"), consisting of (i) 32 units to be located at 21131 Ord Avenue in East Garrison, California, an unincorporated community in the County of Monterey (the "County"), to which not more than \$14,000,000 of principal amount of Bonds will be allocated, and (ii) 34 units to be located at 21231 Ord Avenue in East Garrison, California, to which not more than \$16,000,000 of principal amount of Bonds will be allocated, and \$16,000,000 of principal amount of Bonds will be allocated. The Proejct is to be owned and operated by a limited partnership or other entity to be created by CHISPA, Inc., or an affiliate thereof (such limited partnership or other entity being referred to herein as the "Borrower").

The Bonds and the obligation to pay principal thereof and interest thereon and any redemption premium with respect thereto do not constitute indebtedness or an obligation of the County of Monterey, the Authority, the State of California or any political subdivision thereof, within the meaning of any constitutional or taxing powers of any of them. The Bonds shall be a limited obligation of the Authority, payable solely from certain revenues duly pledged therefor and generally representing amounts paid by the Borrower.

The hearing will commence at 1:30 p.m., or as soon thereafter as the matter can be heard, and will be held on the first floor of the Monterey County Government Center, Board of Supervisors Chambers, at 168 W.
