## AMENDMENT NO. 3 TO SERVICES AGREEMENT BETWEEN CALIFORNIA TRANSPLANT SERVICES, INC. dba SAFETYGRAFT AND NATIVIDAD MEDICAL CENTER FOR TISSUE BANK SERVICES

This Amendment No. 3 to the Services Agreement ("Agreement") which was effective on December 15, 2015 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and California Transplant Services, Inc. dba SafetyGraft (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

## RECITALS

**WHEREAS**, the Agreement was executed for Tissue Bank Services with a term January 1, 2016 through December 31, 2020 and a total Agreement amount not to exceed \$175,000; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on August 5, 2020 to extend for one (1) year period (January 1, 2021 through December 31, 2021) and to add an additional \$57,500 for a total Agreement amount of \$232,500 with no changes to the scope of work; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on October 22, 2020 to add an additional \$17,500 for a total Agreement amount of \$250,000 with no changes to the term or the scope of work; and

**WHEREAS**, NMC and CONTRACTOR currently wish to amend the Agreement to add an additional \$17,500 for a total Agreement amount of \$267,500 with no changes to the term or the scope of work.

## **AGREEMENT**

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement, Amendment No. 1, Amendment No. 2 and Amendment No. 3 incorporated herein by this reference, except as specifically set forth below.

1. Section 2 / Paragraph titled, "PAYMENTS BY NMC" shall be amended to the following: "NMC shall pay the CONTRACTOR in accordance with the payment provisions set forth in EXHIBIT A as per Original Agreement. The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$267,500"

- Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement, in Amendment No. 1, in Amendment No. 2 and in Amendment No. 3.
- 3. A copy of this Amendment No. 3 shall be attached to the Agreement.
- 4. This Amendment No. 3 shall be effective when both parties have signed.
