RENEWAL AND AMENDMENT No. 3

To Agreement for Lease of Printers and Service & Supplies By and Between

County of Monterey and Monterey Bay Office Products, INC.

THIS RENEWAL AND AMENDMENT No. 3 to the Standard Agreement for the lease of one printer, service, and supplies, is made and entered into the <u>1st</u> day of October 2021 by and between the County of Monterey, a political subdivision of the State of California (hereinafter, "COUNTY"), and Monterey Bay Office Products, INC., dba Monterey Bay Systems (MBS), (hereinafter, "CONTRACTOR").

WHEREAS, COUNTY and CONTRACTOR entered into a Standard Agreement, for the term of October 1, 2017 to January 31, 2019, with an amount not to exceed \$5,000; and

WHEREAS, on or about February 22, 2018, the COUNTY and CONTRACTOR entered into Amendment 1 to the Agreement, thereby amending the Agreement, to extend the term to January 31, 2021 and to increase the total contract amount to \$16,000;

WHEREAS, on or about May 28, 2021, the COUNTY and CONTRACTOR entered into Amendment 2 to the Agreement, thereby amending the Agreement, to extend the term to June 30, 2021;

WHEREAS, the parties' Agreement expired on June 30, 2021; and

WHEREAS, COUNTY and CONTRACTOR wish to renew and amend the Agreement to allow continuation of services and payment for services and to extend the term of the Agreement for one year;

AGREEMENT

NOW THEREFORE, COUNTY and CONTRACTOR in consideration of the mutual agreements contained in the Agreement herein, agree as follows:

- 1. Section 3.01 shall be deleted and restated in its entirety to read as follows,
 - "The term of this agreement is from October 1, 2017 to June 30, 2022."
- 2. Except for the Amendments set forth, all other terms and conditions of the original Agreement shall remain unchanged and unaffected by this RENEWAL AND AMENDMENT No. 3 and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of RENEWAL AND AMENDMENT No. 3 shall be attached to the original AGREEMENT dated on or about February 22, 2018.
