**WHEREAS**, the County is establishing new bargaining units, designated as Unit A-OS for the Deputy Sheriff-Operations classification and Unit B-OSS for Sheriff's Investigative Sergeant classification, and has established Unit SPD for the Staff Nurse II – PerDiem and Nurse Practitioner III – Per Diem classifications:

**WHEREAS**, the Personnel Policies and Practices Resolution No. 98-394 Section VI Employee/Bargaining Units is amended to add Unit A-OS, Unit B-OSS and Unit SPD for the classifications identified above;

- 1. Bargaining Unit A-OS is designated for the Deputy Sheriff-Operations classification and Unit B-OSS is designated for Sheriff's Investigative Sergeant classification.
- 2. The Personnel Policies and Practices Resolution No. 98-394 Section VI Employee/Bargaining Units is amended to add Unit A-OS, Unit B-OSS and Unit SPD Staff Nurse II Per Diem and Nurse Practitioner III Per Diem classifications)
- 3. The Human Resources Department is directed to create Unit A-OS, Unit B-OSS and Unit SPD in the HRM Advantage System.
