Board Comments

Supervisor Alejo wished all mothers a belated Happy Mother's Day .

Supervisor Luis Alejo advised an unidentified 23 year old young man was shot to death just before Mother's Day and last night Emilio Barrera, age 41, & Antonio Ortega, age 28, were shot in Salinas. This happens too often in the community These are our brothers and sisters and community members. He was reminded that a young man was murdered last year on Mother's Day. It was not gang related. He had no previous incidents and was working on his Jeep. It's saddening and hurtful to the community when these senseless deaths occur. He encouraged everyone to take a moment to reflect and ask, as policy makers & law enforcement, what can we do better to stop the violence. He noted that last year when he was in the Legislature, he secured \$5.5 million in public safety resources for the City of Salinas. This was the only city to receive an allocation and it took five years to get these monies added to the budget. He hopes that the County and City of Salinas can find new strategies to address this issue, so families can live safely in the community. He asked for prayers for the 18 families that have lost loved ones this year.

Supervisor Mary L. Adams expressed support, on behalf of the Board, for Supevisor Luis Alejo's comments and the families that have lost loved ones in Salinas, as well as support for working together to find solutions to gang violence in the community.

Supervisor John M. Philips thanked Monterey County Animal Control Services for the free licensing and vaccination clinic in Castroville. His staff volunteered at the event. There was a good turnout. Quite a few folks came to have their animals vaccinated. It was a worthwhile event.
