#### **6.** Board Comments

Supervisor John M. Phillips made no comments this week.

Supervisor Chris Lopez commented they had a great community Town Hall last Friday down in San Ardo in a tiny community with about 500 people; about a tenth of the population were there; they had about 50 people in the room and heard directly from that community on what they're needs and desires are; the primary need was repaving the roads and making sure large commercial traffic was redirected to the outer edges of town and not through the center of town; the turnout was good and partners were there from Waste Management Department and Environmental Health; this is a great model that is going to be followed through with the rest of the communities in South County starting next week in Lockwood.

Supervisor Mary L. Adams commented the California State Association of Counties is holding a regional meeting in Monterey, at the Hyatt, regarding housing and homelessness; it takes place this week on Wednesday, Thursday and Friday; Supervisor Alejo who serves on the CSAC Board will be presenting with them; this is exciting and hopefully they will receive some good information on the housing issue and also sharing some; secondly the California Coastal Commissioner, Supervisor Carol Groom from San Mateo, who represents our area, is coming to Monterey on Friday for a series of community meetings primarily in Big Sur and the Carmel Highlands on issues in those areas; it is exciting to have her here and to show her around.

Supervisor Luis A. Alejo reiterated it is an honor for Monterey County to be hosting this regional meeting with dozens of county supervisors and staff here to focus on this critical issue on housing and homelessness which is hosted at the Hyatt Hotel in Monterey; he hoped all can stop at some of the events that are happening to show support including our County Administrative Officer and County Counsel; we want to be a good host and welcome folks when they are coming to our area to have these important policy and budget discussions; secondly he also invited, the public, on March 31st which is the last Sunday of the month at 10:00 a.m. to the annual Cesar Chavez Day march which is a moment to reflect on the hard-working people of our County; the people who are the backbone of our economy and the hard-working people who sacrificed so much to better their children and families and next Tuesday he requested that once again there is a Farm Worker Appreciation Day; he stated that we are one of the few counties in California that passed a resolution recognizing the hard work of the people in the fields that put food on tables all across our nation and he looks forward to that next week and also to March 31st at 10:00 a.m. at Cesar Chavez park in East Salinas for the march.

Supervisor Jane Parker mentioned this past week and weekend she attended a conference of the Local Government Commission and Calcog, a joint conference, that is always a very interesting set of a presentations; there were two that were particularly intriguing she will be talking to people in our area about; one is a different model for transit that's much more responsive and successful in getting more people to use transit; it is a crossing of the on-demand Uber and Lyft model with a smaller bus that can take people not

always door-to-door unless they are disabled but they call it Pointish to Pointish it can take them within about a block or so of where they are or where they want to get which seems to be a very effective pilot that is going on in West Sacramento; secondly another presentation they had was from the U.C. system talking about a way to combine the desire to decrease fire risk in forests by getting some of the plants removed which is a form of a good forest management perspective and then also to create jobs and reliable building materials so they have a lot of research about this and are willing to partner with local folks to create jobs and help reduce the risk of wildfires which is a win win for communities.
