Supervisor Chris Lopez commented they had a great listening session, in King City, last week the desires of the King City community is additional assisted living opportunities and opportunities for youths specifically for after hours from the ranges from 7:00 p.m. to 10:00 pm in the community which was the outcome of the meeting which he was glad to get that fresh perspective from folks, they also have in town this week the 125th Annual Sheriffs Conference, he wasn't able to make it out to the breakfast this morning but he wanted to welcome the sheriffs to Monterey County, lastly he will be submitting a referral next week asking staff to determine the validity of the claims and short comings of the County facilities on Aguajito Road specifically the rat infestation problem they have heard about so he just liked to make sure if there is a problem that it be addressed as soon as possible.

Supervisor Mary L. Adams commented on the rats as she has had them in her office and the remains are quite clear there's also like a pack rat or something that creeps around underneath the floor but now we put everything in plastic bags sealed so they aren't bothering us but if you have chocolates in my office know that they're sealed in plastic so that they are not eaten because they've eaten the bag of chocolate before but that's not nearly as important as other things that we have in our County in our district that just want to draw attention to the fact that we have an extraordinarily successful Big Sur Marathon this past weekend every single solitary event in the entire program of activities just sold out so we have more than 20,000 people participating in the event it was really wonderful weather couldn't have been better and it's just such a fine opportunity to really promote health and wellness throughout the whole County by so many great different approaches to it; she did the 11 miler and

felt pretty proud of herself.

Supervisor John M. Phillips shared in his jurisdiction that Public Works then great job and getting Kirby Park opened should be opened around May 2nd or May 3rd.

Supervisor Luis A. Alejo commended all the organizers for the Asian American Festival that took place in Salinas' Chinatown on Saturday, it celebrated and had the involvement of the Filipinos, the Chinese and the Japanese American communities in Salinas; it was a great celebration with good food and a car show with dance, traditions and culture; thereafter, they had the UC Berkeley alumni luncheon at Laguna Seca golf course honoring all the students in the Monterey Bay that have been accepted to UC Berkeley; it was beautiful to celebrate with their families and the younger brothers and sisters as they take off to attend Cal, it was nice to have guite a few students from Salinas who were accepted and are on their way there in a few months; he also talked about two committees today at 4:00 p.m. to 5:30 p.m. the City of Salinas is having their Westside area study session for upcoming proposed housing to focus on the first phase which is going to propose to build the first 4300 homes in that area around Lowe's; there is three phases to the whole corridor post housing but it is the first phase that seems to be close to moving forward so he wanted to encourage the Salinas residents to participate as we know that housing is a big crisis but this is the first potential area where we can actually break ground and start building those homes that our local residents are asking for including rental units; last thing he wants to encourage our residents and community leaders and elected leaders from South Monterey County to attend Seaside City Council meeting this Thursday at 5:30 p.m. as they going to be talking about feasibility study about a new courthouse which caught many of us by surprise because all our conversations with the local Superior Court were only about putting land aside for potential replacement to the Monterey courthouse in Seaside but it was never pre-empting or betraying the community that has long been promised a courthouse; he's been waiting for 10 years and when he saw a copy of the letter that was sent last September which we were never provided with the language it is clearly indicated intent and a different strategy for the court to prioritize another peninsula courthouse over South County; he was very passionate about it and he had no meltdown but there was a lot outreach from his perspective unlike his friends at The Weekly who reported because there were some disingenuous arguments being made; there is no rat infestation (1) one rat or mouse is not infestation; he shared there are no problems with asbestos, plumbing or electrical; yes it's an older building but probably does not pose a risk to staff or the public; it is completely different and generally fabricated claims about it not being seismically safe even though it endured the 1989 Loma Prieta earthquake; it's also not found in fact; he's met with RMA staff to ask these questions and he just wanted to put that out there but because timing is of the essence; the court is ranking as the legislature or the Judicial Council has to re-rank all the projects, not the top10, as those were funded last year but all the projects are being reranked and that is going to come out soon; he is very concerned because there's been at least a couple visits from the Judicial Council staff regarding at Seaside courthouse but there hasn't been a single phone call, a single conversation nor a single visit from the Judicial Council regarding the Greenfield courthouse and that worries him; what conversations are happening between the Courts and Judicial Council behind closed doors; he does not want to be surprised later about that courthouse, he was just speaking about, the first time a few months

ago, will preempt the Greenfield courthouse which has been waiting for over 10 years and that's the real concern he has; he wants to be clear unlike what the news reported the legislature will not approve two courthouse projects in the same County, in the same funding cycle; the court has previously acknowledged that and he used to be a part of the Court's budget subcommittee and he knows that will not happen so he just wanted to be realistic to the public on what will be funding, at a time; it will take several years to get a second one down the road but he said; he suggested to the Court andh he's telling them now that we should work together for a new courthouse but let's take care of promise to Greenfield first and then let's work together to fulfill and look for another site together, in another part of the County, second he thinks that's fair and we can do it together; he thinks that's what is equitable and that would be fair to the people of South County and it's the way we could work collaboratively rather than behind closed doors pushing one project over another.
