Supervisor Chris Lopez commented that there is another listening session tonight in Greenfield. They will be starting the session about 6:00 p.m. at City Hall if anybody is available and wants to share some thoughts that'll be the time. He also attended the Salinas Valley Fair this past weekend which one extremely well. They sold two cows for nearly \$70,000 to benefit the family and JT who is battling a rare genetic disease here in the Salinas. The community really stepped up to make sure that we were we were taking care of our own. He was proud to take part in the long day of helping kids sell their animals as this is a vital historical legacy in the Salinas Valley.

Supervisor Mary L. Adams shared they participated in a ribbon-cutting called the Key Coin Healing collaborative that is wonderful with horses sharing and caring which is a special thing. Then also they had the opportunity to join in the celebration of the Meals on Wheels Woman of the Year honoring Diane Bruno a Pebble Beach resident that does so much for our community and has for such a long time a very low-key way. As a son of Vietnam era veteran, he thanks all our veterans and the sacrifices they made. In the last few years, during his time in the state legislature, we had several young people die from combat in from Salinas, Marina, Greenfield and all parts of Monterey County and it is these moments that we honor and remember their sacrifice, service and the sacrifice their families are still suffering. Diane Jimenez, our local Social Services heads this up and we want to make sure everybody knows about this.
