Supervisor Luis A. Alejo reminded all that today is Election Day that a lot of people sacrificed, and they put their life on the line for us to have the opportunity and the fundamental right under our constitution to be able to vote. He encouraged young people and elders in our community today and in the last few hours to go to vote and or drop off their ballots.

Supervisor Mary L. Adams commented on a few items. She shared she was not present at the last board meeting on February 25, 2020, as she was in Washington D.C. to meet with our elected officials in her capacity as a member of the Monterey Peninsula Water Management District board. It was a successful meeting being able to talk one on one with the elected people back there and let them know about the local's perspective some of the key issues that matter to us to ensure that we are on the same page when it comes to issues surrounding water particularly. She also gave a shout out of thanks to Senator Monning and Congressman Panetta for their efforts to bring in the California Insurance Commissioner Ricardo Lara. They had a meeting with him and a number of impacted property owners and other stakeholders who are experiencing this issue of fire insurance cancellation in the County. It is an emerging problem for numerous residents in the 5th District and her office has been able to connect folks with potential assistance with this key issue of concern.

Supervisor Jane Parker commented a little later this week she will be attending a conference of the local government commission. It is an organization that looks at developing sustainable policy as it relates to transportation, land use, water, economic development and housing. One of the neat things is it is held at Yosemite each year which is really an inspiring place to be learning about how to think sustainable about the work we want to do to make our communities a better place.

Supervisor Chris Lopez had the opportunity to do a little read Across America at the Monterey County free libraries this weekend down in Greenfield. He'll get the opportunity to do it again on Friday at the San Lucas school. It is incredible to see the turnout and the tie our community has to our key places including our libraries. They really support us in the efforts we make in providing that service and because of that he wanted to talk about census. Census is March 12th is when it kicks off even though the official date is April 1st we have to make sure these vital resources continue to be in the communities that need them. This only happens when we get a complete count which means we all need to get counted and everybody needs to be all in on this. This leads him to his last comment which is "All In" and is the motto at the San Antonio Unified School District who had an open house this weekend to show off their brand new facilities that were paid for by local bonds voted on by local taxpayers. This school district has an incredible new electric and diesel bus and a brand new library, community room and classrooms as well as administration offices. This is a small school district that went all in to make sure that it was possible for them to provide the best education to some of our students in the most rural areas of our community. He commended them on this great achievement and wisely spending taxpayers dollars. So many community members came out to visit to see their tax dollars at work and there were only positive comments to be had.
