SUMMARY/DISCUSSION:

The U.S. Department of the Interior's ("Department") WaterSMART (Sustain and Manage America's Resources for Tomorrow) Program provides a framework for federal leadership and assistance to stretch and secure water supplies for future generations in support of the Department's priorities. Through WaterSMART, the Bureau of Reclamation ("Reclamation") leverages federal and non-federal funding to work cooperatively with states, tribes, and local entities as they plan for and implement actions to increase water supply reliability through investments in existing infrastructure and attention to local water conflicts. The maximum grant award available is \$2,000,000 with a 50% cost-share.

Drought conditions across the West impact a wide range of communities and sectors, including agriculture, cities, tribes, the environment, recreation, hydropower producers, and others. The Western United States is experiencing its worst drought this century-historic in both duration and severity-threatening to kill crops, spark wildfires, and harm public health. As of July 2021, the U.S. Drought Monitor indicates that more than 93% of the land in nine of the Western states is in drought conditions, and nearly 60% of the area is experiencing extreme or exceptional drought. The WaterSMART Drought Response Program supports a proactive approach to drought by providing financial assistance to develop and update comprehensive drought plans ("Drought Contingency Planning") and implement projects that will build long-term resilience to drought ("Drought Resiliency

Projects").

Monterey County is experiencing a second year of dry and drought conditions and was included in the Governor's drought declaration in June 2021. These conditions have affected the local water resources with two of the critical reservoirs serving the area at 7 and 12% capacities and groundwater levels in southern Salinas Valley beginning to decline. The lack of water in storage in the reservoirs this year resulted in the curtailment of releases to the groundwater basin in July, two months earlier than normal. Since then, only minimum fisheries releases are being made from the reservoirs. As a result, there is no flow in the Salinas River from near King City to the coast.

The Monterey County Water Resources Agency ("MCWRA") manages the Castroville Seawater Intrusion Project ("CSIP"), which is part of a conjunctive use system that delivers a combination of recycled water, Salinas River water, and groundwater to farmers to reduce groundwater extraction within seawater intruded areas of the 180/400-Foot Aquifer Subbasin. CSIP is owned by the MCWRA and is operated by Monterey One Water ("M1W"). Over the 23 years since CSIP was built, the system has already slowed the rate of seawater intrusion, but it is limited by the inability to meet all pressure and flow demands during peak summer irrigation during periods of drought, due to restrictions in capacity along some critical pipeline segments. Groundwater must be pumped to increase pressure at some sites when demand peaks during certain hours and conveyance needs exceed pipeline capacities. The existing infrastructure does not allow for continuous monitoring of "turnouts" (points of use for irrigation), nor for effectively scheduling and managing water deliveries.

The MCWRA has proposed the CSIP optimization projects ("Optimization Projects") to address these challenges through infrastructure and program implementation improvements. The Optimization Projects include the installation of devices to track and control water use at each turnout, which enables water scheduling, creation of algorithms for meeting demands, and identifying the most critical conveyance deficiencies. In addition, it includes dynamic hydraulic modeling of various conditions of existing and future seasonal and diurnal water use. The Optimization Projects implement a water scheduling system whereby farmers submit water orders and water deliveries are scheduled to increase the use of recycled and river water. Finally, the Optimization Projects include upgrades to a critical pipeline segment, the A-1 monitoring site, to convey higher flows and optimize pressure.

This set of improvements will decrease the system's need for groundwater during peak hours of demand throughout the year. Optimizing the CSIP system in this way will increase recycled water supply reliability and will help protect drinking water supplies of underrepresented, disadvantaged communities in Castroville and Salinas, which are threatened by seawater intrusion. In drought years, the annual groundwater pumping reduced due to the Optimization Projects is anticipated to be 1,200-1,600 acre-feet. The components of the Optimization Projects are in various stages of the design phase and could be completed within the next couple of years, if adequate funding is secured. The total estimated cost for these improvements is approximately \$4 million. The subject grant has a 50% cost-share with a \$2 million maximum grant award. As such, the match by MCWRA would be up to \$2,000,000.

An official resolution adopted by the applicant's governing body, to commit the applicant to the financial and legal obligations associated with receipt of a financial assistance award under the notice of

funding opportunity, is a requirement for grant submittal. The resolution was drafted in accordance with grant guidelines for consideration by the Monterey County Water Resources Agency Board of Supervisors. (Attachment A).

This item was presented to the Monterey County Water Resource Agency Board of Directors at the September 20th, 2021 meeting who recommended that it move forward to the Board of Supervisors for approval.

Authorize the Water Resources Agency General Manager, or designee, to:

- a. Apply for a \$2,000,000 WaterSMART matching grant with the U.S. Department of Interior, Bureau of Reclamation ("BOR") Drought Response Program (Notice of Funding Opportunity No. R22AS0020) for Castroville Seawater Intrusion Project optimization projects; and
- b. If the grant is awarded, enter into a cooperation agreement with the BOR, receive the funds, and administer the grant.

WHEREAS, the U.S. Department of Interior, Bureau of Reclamation ("BOR") Notice of Funding Opportunity is issued under the authority of Section 9504(a) of the Secure Water Act, Subtitle F of Title IX of the Omnibus Public Land Management Act of 2009, Public Law (P.L.) 111-11 (42 United States Code (U.S.C.) 10364), as amended, and the Fish and Wildlife Coordination Act, 16 U.S.C. 661-666c, as delegated to Reclamation in Departmental Manual 255 DM 1.1B; and

WHEREAS, applicants for grant funding from the 2022 BOR WaterSMART Grant Program are required to adopt a resolution pursuant to the provisions of the grant application and cooperative agreement; and

WHEREAS, the Monterey County Water Resources Agency ("MCWRA") in cooperation with Monterey One Water, currently provides recycled water to approximately 12,000 acres of irrigated agriculture within the Castroville Seawater Intrusion Project ("CSIP"), through the Monterey County Water Recycling Projects, but the system is constrained and has a need for funding assistance to increase drought resiliency and improve the reliability of water supplies and water management; and

WHEREAS, there are potential projects to optimize the CSIP Distribution System resulting in decreasing the system's need for groundwater during peak hours of demand throughout the year. Optimizing the CSIP system in this way will increase recycled water supply reliability and will help protect drinking water supplies of underrepresented, disadvantaged communities in Castroville and Salinas, which are threatened by seawater intrusion; and

WHEREAS, MCWRA will only enter into a cooperative agreement with the BOR if an award is made. The grant will provide funding assistance for the CSIP Distribution System optimization projects. The proposed projects will allow the MCWRA to increase drought resiliency and improve the reliability of water supplies and water management; and

WHEREAS, the MCWRA General Manager, or designee will conduct all negotiations and execute and submit all documents, including, but not limited to, a grant contract and amendments,

and to work with the BOR to meet established deadlines for entering into a cooperative agreement; and

WHEREAS, MCWRA has reviewed and supports the application submitted to the BOR for consideration. MCWRA has confirmed that it has the capability to provide the amount of funding and/or in-kind contributions as specified in the funding plan of the application; and

WHEREAS, an application is due to the BOR on October 5, 2021.
